For those of you headed to Nashville for the ASLA National Conference in a couple of weeks- Enjoy! Until then- look forward to what lies ahead.





Keith Bowers gave the presentation for the 2021 Doug Crowell lecture series, hosted by VTASLA and sponsored by Read Custom Soils. The event was held live over zoom in October.

Keith Bowers is the Founder and President of Biohabitats, an ecological consulting firm he established in 1982. Biohabitats mission is to inspire communities to rediscover a sense of place through preserving indigenous ecosystems, restoring biological diversity, and embracing ecological stewardship. Through research, planning, design, and construction, the Biohabitats team seeks to restore ecosystems, conserve habitat, and regenerate the natural systems that surround us. The company was just recognized as "Best For The World" in July 2021 as a certified B Corp for its company governance promoting team responsibility and accountability. Keith is a Landscape Architecture Fellow and serves on various Boards including the Rewilding Institute.



NATIONAL PRESERVATION AWARDS SHOWCASE THE LEADERS IN PRESERVATION

PATRICIA M. O'DONNELL, PRESERVATION LANDSCAPE ARCHITECT AND PLANNER, OF CHARLOTTE, VERMONT RECEIVES THE CROWNINSHIELD LIFETIME ACHIEVEMENT AWARD IN PRESERVATION

Patricia M. O'Donnell, a Charlotte, Vermont landscape architect and planner was honored with the Louise du Pont Crowninshield Award for Lifetime Achievement during the National Preservation Awards Ceremony on the evening of Thursday, November 4. This pinnacle recognition from the National Trust for Historic Preservation, was presented to ODonnell for her "indisputable evidence of superlative achievement in the preservation and interpretation of our heritage."

O'Donnell is a nationally and internationally recognized landscape architect and planner. As noted at the ceremony Thursday evening, her "pioneering work over the past 40 years helped to establish the field of cultural landscape preservation in the United States and has continued to expand it by combining scholarship with the holistic stewardship of public places. ... her current focus on climate change action, sustainability, accessibility, and inclusion demonstrate that she continues to be a powerful force for innovation in her cultural landscape practice." Patricia O'Donnell is the first professional landscape architect recognized with the Louise du Pont Crowninshield Award in its more than sixty-year history.

Paul Edmondson, president and CEO of the National Trust for Historic Preservation said "This year's PastForward theme is Lead the Change, and our award recipients truly are doing just that for particular places and for the national preservation movement. It is an honor to present the Louise du Pont Crowninshield Award for Lifetime Achievement to Patricia M. O'Donnell for the important work she is doing both nationally and internationally." Her contribution to the National Park Service committees set national standards for how we steward the layered richness of our cultural landscapes, and she played key leadership roles in the creation of both the documentation-focused Historic American Landscape Survey and the advocacy-oriented Cultural Landscape Foundation.

In 1987, O'Donnell founded her pioneering firm, Heritage Landscapes, which has completed over 600 cultural landscape preservation planning and implementation projects. Her portfolio includes hundreds of places listed on the National Register of Historic Places, 40 National Historic Landmarks, and 8 World Heritage Sites. O'Donnell's current endeavors focused on climate change action, sustainability, accessibility, and inclusion demonstrate that she continues to be a powerful force for innovative in her cultural landscape practice.

This important accolade follows the American Society of Landscape Architects Firm Award presented to Heritage Landscapes in 2019, and recognized by the State of Vermont legislature in House Concurrent Resolution No. R-319 (H.C.R.262). Founder and Partner of Heritage Landscapes LLC, in Vermont O'Donnell had aided in preserving and revitalizing the character and uses of the landscapes at Shelburne Farms and the Joseph Smith Birthplace, two local National Historic Landmarks, among the company's 600 projects around the globe since 1987.



MORE AWARD NEWS!

Even though it seems like we just finished up the Public Places Awards and our 2020 Chapter Awards ceremony was just last spring, it's time to start thinking about your entries to the 2022 VTASLA Chapter Awards Program! Entries will most likely be due near the end of February, 2022. Be on the lookout for more information on the schedule in December.

Our award submissions are usually juried by another ASLA chapter and VTASLA typically reciprocates the service for that chapter. We try to partner with chapters of similar size but that is not always easy. The 2020 Chapter Awards Program entries were juried by the Alaska Chapter. In September, VTASLA returned the favor by assembling a jury to review their award submissions. Jim Donovan chaired an on-line jury with VTASLA members Keith Wagner, Elizabeth Cadwell, David Raphael, and Jeff Hodgson, as well as former VTASLA Chapter President David Jacobs, who joined from Tashkent, Uzbekistan. The jury met for about two hours and gave out two Awards of Excellence, five Honor Awards, and seven Merit Awards.

The 2022 VTASLA Chapter Awards will by juried by the Alabama Chapter. In this case, their awards program was scheduled before ours, so Jim once again chaired an on-line jury last month with the same group, with the exception of David Raphael, who had a scheduling conflict. After lively debate, they settled on bestowing six Honor Awards, and sixteen Merit Awards to projects out of a rather large group of submissions.

Serving on an awards jury is an interesting and enjoyable process. Not only do you get to see a wide range of projects types from other parts of the country, but you also get to participate in a lively discussion about design, the design process, and the work of landscape architects. If you get the chance to serve on one, you should jump at it! A few images from the award-winning projects from Alaska and Alabama are included here.

NEW "ENERGY GOALS" REQUIREMENT

UPDATE FROM THE VERMONT OFFICE OF PROFESSIONAL REGULATIONS FOR LICENSURE

To: Affected Licensees

From: The Office of Professional Regulation

Date: June 26, 2021

Re: New "Energy Goals" Requirement



In 2020, the General Assembly passed Act 178, which requires certain professionals licensed by OPR to complete an education module related to the State's energy goals as a condition of license renewal. See Act 178 (2020), Sec. 33. This requirement takes effect on July 1, 2021.[1]

The law applies to: (1) architects, (2) landscape architects, (3) pollution abatement facility operators, (4) water system designers, (5) professional engineers, (6) property inspectors, (7) real estate appraisers, and (8) real estate brokers and salespersons. The law also applies to some Vermonters licensed by other State agencies, such as the Department of Public Safety.

What is Required?

To help you meet the new requirement, OPR has partnered with other agencies to produce a PowerPoint that offers a concise, general orientation to the State's energy goals. These goals are derived from specific acts of the General Assembly.

You can view the orientation module here. Doing so now will save you time when you renew.

At the first upcoming renewal, the application form will require that you affirm having completed the orientation module linked above. It cannot be counted toward continuing education or competency requirements.

At each biennial renewal after the next, the law will require that you affirm having completed an education module specific to your profession's role in meeting the State's energy goals. By that time, environmental groups, state agencies, professional associations, and purveyors of green-energy products and services, will very likely offer a menu of free or low-cost options that satisfy the new requirement. Many of these will be eligible for continuing education credit in fields that require CE.

Please contact us if you have questions regarding this requirement.

[1] Pollution abatement facility operators: Although your renewal period opened in June, the effective date of your renewed license will be after July 1, 2021. Consequently, the new requirement applies to your current renewal.
